The Principal, RCU Govt PG College Uttarkashi, Uttarakhand invites item rates in sealed tenders for the supply and installation of equipments as per following **TERMS & CONDITIONS**:

1. The Principal reserves the right to reject any or all the tenders at any stage without assigning any reason thereof.
2. Conditional tenders shall not be accepted.
3. Tender can be placed for one or more items/equipments.
4. Rates should be inclusive of all taxes, packing charges, transportation etc.
5. Any item or quantity of items can be changed without prior intimation to the tenderer.
6. Technical and Financial bids should be separately sealed in envelopes clearly inscribing 'Technical Bid' and 'Financial Bid' respectively. Envelope containing Financial Bid will be opened only if the Technical Bid is accepted. Technical bid should be accompanied by photographs of the goods intended for supply.
7. Following documents are to be attached with the tender form:
 - Non-blacklisting certificate of firm
 - PAN Number of firm
 - GST Number of firm
 - Income tax Return of last two years
 - Registration validity certificate from authorized department
 - Recognised Supplier / Servicing / Authorization certificate of the manufacturer / firm represented by tenderer.
 - Tender fee of Rs. 1000/- in the form of demand draft of nationalized bank in favour of Principal, RCU Government Post Graduate College Uttarkashi, Uttarakhand. Tender forms can also be purchased from college office by paying the fee in cash.
 - Earnest Money (EMD) stipulated @ 2% of the price being quoted by supplier in the form of demand draft of nationalized bank in favour of Principal, RCU Government Post Graduate College Uttarkashi, Uttarakhand.
 - Experience certificate/proofs of working with Government Departments.

8. The rates quoted by the tenderer should be for make, model or specifications given in tender form. Other make, model and specifications shall not be accepted.
9. The equipments should be of the said specifications and have at least one year guarantee or otherwise specified.
10. It is essential to enclose the make/company name/model number and other specifications/ product catalogue of the item tendered.
11. The supplier whose tender is approved shall appear in the college within 15 days for the execution of bond/contract/agreement of Non-Judicial Stamp worth Rs. 100/-.
12. The supplier whose tender is approved shall have to furnish the PERFORMANCE SECURITY in the form of FDR of nationalized bank in favour of Principal, RCU Government Post Graduate College Uttarkashi, Uttarakhand. The amount of PERFORMANCE SECURITY/FDR shall be stipulated @ 10% of the price quoted by the supplier. The FDR may be released by Principal after three months of the delivery of goods provided the end user and committee authorized by Principal are satisfied with the functioning/performance of the supplied goods.
13. The supplier whose tender is approved will have to supply, install and demonstrate the equipment within two weeks commencing from the acceptance of his tender by the Principal failing which the earnest money annexed may be forfeited.
14. The payment will be made only after the supply, installation and demonstration of the equipments and its verification by the Principal or the committee authorized by the Principal for this purpose.
15. GST & TDS will be deducted on payments as per the Government rules.
16. Any dispute to the supply of the items shall be referred to the Court at Uttarkashi.
